7. OTHER INFORMATION (Section 51(1)(f) of the Act)

The Minister of Justice and Constitutional Development has to date not published and regulations in terms of this section.

8. AVAILABILITY OF THE MANUAL (Section 51(3)(f) of the Act)

- ▶ This manual is available for inspection at the offices of “the Company” free of charge – Monday to Friday, 8am to 5pm.
- ▶ Copies of the Manual may be obtained, subject to the prescribed fees, at the offices of “the Company”.
- ▶ The Manual may also be accessed on the website of the SAHRC (www.sahrc.org.za). The request forms and fee structure can be obtained on the SAHRC website (www.sahrc.org.za) or the website of the Department of Justice and Constitutional Development (www.doj.gov.za) (under “regulations”).

9. MANNER IN WHICH REQUEST FOR ACCESS IS TO BE MADE (SECTION 51 (e))

- ▶ The requester must complete Form C (a copy of which is attached hereto) and submit this form together with a request fee to the head of the private body;
- ▶ The form must be submitted to the head of the private body at his/her address, fax number or electronic email address.
- ▶ The form must:
 - Provide sufficient particulars to enable the head of the private body to identify the record/s requested and to identify the request;
 - Indicate which form of access is required;
 - Specify a postal address or fax number of the requestor in the Republic;
 - Identify the right that the requestor is seeking to exercise or protect;
 - And provide an explanation of why the requested record is required for the exercise or protection of that right;
 - If in addition to a written reply, the requester wishes to be informed of the decision on the request in any other

manner, to state that manner and the necessary particulars to be informed in the other manner, if the request is made on behalf of another person, to submit proof of the capacity in which the requestor is making the request, to the reasonable satisfaction of the head of the private body.

10. PRESCRIBED FEES (Section 54)

- ▶ A requester is required to pay the prescribed fees (R50.00) before a request will be processed.
- ▶ If the preparation of the record requested requires more than the prescribed hours (six), a deposit shall be paid (of not one third more than the access fee which would be payable if the request were granted)
- ▶ A requestor may lodge an application with a court against the tender/payment of the request fee and/or deposit;
- ▶ Records may be withheld until the fees have been paid
